## Injury Waiver

In consideration of participating in ice skating activities, I/The Participant's Guardian represent that I/The Participant's Guardian understand the nature of figure skating activities ("activity") and that my child is qualified, in good health, and in proper physical condition to participate in such "activity". I/The Participant's Guardian acknowledge that if I/The Participant's Guardian believe event conditions are unsafe, I/The Participant's Guardian will immediately discontinue my child's participation in the "activity".

I/The Participant's Guardian fully understand that this "activity" involves risks, though rare, of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my child's own actions, or inactions, those of others participating in the "activity", or the conditions in which the "activity" takes place, and that there may be other risks either not known to me or not readily foreseeable at this time; and I/The Participant's Guardian fully accept and assume all such risks and all responsibility for losses, costs, and damages incurred as a result of participation in the "activity".

I/The Participant's Guardian hereby release, discharge, and covenant not to sue Peabody Skating Club Inc. , United States Figure Skating, it's directors, officers, administrators, sponsors, volunteers, agents, employees, staff, instructors, trainers, other participants and if applicable, owners and lessors of premises on which the "activity" takes place (each considered one of the "releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the "releasees" or otherwise, including rescue operations; and I/The Participant's Guardian further agree that if, despite this release, waiver of liability, and assumption of risk, I/The Participant's Guardian, or anyone on my behalf, makes a claim against any of the "releasees", I/The Participant's Guardian will indemnify, save, and hold harmless each of the "releasees" from any loss, liability, damage, or cost which any may incur as the result of such claim.

Peabody Skating Club, Inc. has the right, but not the obligation, to provide rules, regulations and/or ice monitors for Club Ice. I/The Participant's Guardian hereby acknowledge that they shall not be responsible for the supervision of the members at Club Ice.

I/The Participant's Guardian have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I/The Participant's Guardian have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
